





### 3. **Sheet PM-1**:

- i) Gore out old bike lane with white diagonals
- ii) Tie yellow diagonals into existing pavement markings
- iii) Pavement markings for right turn lane need to match city standard for a drop turn lane
- iv) Center arrow within lane





- ii) Add yellow diagonals from station 101+25 to 104+00 spaced every 30'
- iii) Add white diagonals station 104+00 to 104+60
- iv) Change bike lane stop bar to sharks teeth




- v) Shift piano keys to line up with lane markings
- vi) Relocate stop bar to be 4' from crosswalk
- vii) Remove bike lane stencil

viii) For all buffered bike lane striping, the inside lane will be 6" and the outside lane will be 4"




