The following are discussion items for the Pre-Bid Meeting:

- A. This project will be a "University Managed Project" and managed through the SCO Interscope system for change orders, contracting and closeout. Bidders are encouraged to become familiar with this system if they are not prior to bidding.
- B. There will be **one** preferred brand alternate in the base bid.
 - 1. Alternate #1 is the add/deduct price Schneider Electric to provide complete building automation system as described in specifications/drawings.
- C. The bid phase schedule was reviewed, refer to attached agenda for details.
- D. The removal only of the ceiling in the lobby is to be a part of this project, no reinstallation is to be part of this project.
- E. Payment and performance bonds will be required. This will be added to the bid form and NTB by addenda.
- F. SCO inspections will be limited to electrical only. UNCC noted that David Souther (SCO electrical inspector) is on campus Tuesdays only.
- G. System shutdown and changeovers must be reviewed with the University 48 hours prior to any work.
- H. Bids must be received in Facilities Services Building 119 by 10:00 am on April 10. Any mailed or delivered bids must be submitted to Facilities Office (per notice to bidders) by 9:00 am.

- J. Final addenda will be issued by close of business on April 2nd.
- K. No temporary site office is expected or required.
- L. The contractor is permitted to use the restroom facilities in the building.



- M. The University is replacing the ceiling in the Auditorium Lobby as part of a separate project. This contractor will need to coordinate access and work with this contractor.
