Existing façade of Scott Hall also requires repair work for delaminated concrete and precast panels. The Ground and 1st Floors are being gutted to provide reconfigured floor layout. Floors 2 -11 will maintain their current layout for the student rooms with several rooms being decommissioned to provide lounge areas. The center of the each student floors will be renovated to provide larger bathroom areas. At completion of renovation, the new layout will provide 210 rooms which will accommodate 400 students and 10 resident assistants.
