4. Space Requests Recommended for Action

The following requests were presented for review and action:

Kinesiology and Venture - Belk

Ryan Kilmer spoke on behalf of Kinesiology and outlined the department's need for space in Belk due to increased enrollment and associated faculty. David Sperry spoke on behalf of Venture and outlined the advantages of having Venture adjacent to Kinesiology in Belk. Venture would relocate from Cone to Belk if the space request was approved.

- Student Affairs has requested space in Belk Gym for the VENTURE program upon completion of the Health and Wellness Center (URec). The requested spaces and their proposed use is as follows:
 - Rooms 110, 111, 113, 114, 116, 117, and 118 for staff offices
 - Rooms 009/009A for multipurpose room and equipment storage
 - Rooms 108, 109, 112, 115, 119, and 127 for a reception area, conference room, breakroom, workroom, training room, and equipment storage
 - Gym4/130A for a climbing wall
- Kinesiology has requested Belk Gym 005, 006, 008, 009, 011, 023A, 023B, 023C for office space for faculty, staff, students, and advising; equipment and materials storage; classrooms including racquetball courts, fitness center, weight room, two activity rooms, and a small gym for weight training and other courses.
- Jay Raja moved to approve the space request. Keith Wassum seconded the motion and clarified sections of the motion as follows:
 - Room 1920 to be used by KNES before 5:00, and to only allow University Recreation Services to schedule the room after 5:00 (Before 5:00 KNES, after 5:00 URec).
 - Recognizes that Venture is going to vacate all space in Cone except room 234 Room 0023 is for KNES use (includes room 23, 23A, 23B & 23C. Room 0019 is for KNES use Room 120 is for Venture use.
 - Rooms 127 and 108 will be classroom and reception area for Venture. Storage room 009A, adjacent to room 009 is also for use by Venture
- The motion passed.
- Jay Raja referenced the space being vacated in Cone and potential uses of the space. The Cone Study may affect the longer-term use of the space.
