All Pre-Qualified bidders are encouraged to seek minority business participation. The minority participation goal for this project is 30%. See UNC Charlotte "Good Faith Effort" Requirements as shown in Edifice, Inc. bidding requirements.

Each proposal shall be accompanied by a cash deposit or a certified check drawn on some bank or trust company, insured by the Federal Deposit Insurance Corporation, of an amount equal to not less than five percent (5%) of the proposal, or in lieu thereof a bidder may offer a bid bond of five percent (5%) of the bid executed by a surety company licensed under the laws of North Carolina to execute the contract in accordance with the bid bond. Said deposit shall be retained by the owner as liquidated damages in event of failure of the successful bidder to execute the contract within ten days after the award or to give satisfactory surety as required by law.

A performance bond and a payment bond will be required for one hundred percent (100%) of the contract price for all trade packages \$500,000 or more. Payment and Performance Bonds will be required on any two (or more) trade packages that total \$500,000 or more. Exception: A one hundred percent (100%) performance and payment bond will be required for all building envelope trade packages (masonry, roofing, glass & glazing, etc.).

Bids shall be made upon the form of proposal provided by Edifice, Inc. for the applicable trade package. All forms must be filled out completely and accurately with all applicable information.
